

Wallmob country coverage and compliance

Last updated 2020-09-22

The purpose of this document is to describe where Wallmob is compliant with various legislation. It also states what to consider and check when installing or using wallmob in various countries.

As wallmob is an open platform available on the web it can be accessed from any country in the world. However the wallmob POS is available through Apple App Store only in countries where it is available or compliant for at least one type of business. In some countries legislation is dependent on the type of business, so please check this document for compliance.

More information on various legislation can be obtained from Extenda Retail Country Handbooks where available and upon request.

Supported countries

Denmark

- No fiscal legislation or special rules.
- VAT rates are set up and adjusted annually if changed.
- Base currency is DKK.
- Danish translation available.
- Live customers using Wallmob.

Norway

- Product declaration on Kassalova is found here.
- VAT rates are set up and adjusted annually if changed.
- Base currency is NOK.
- Norwegian translation available.
- Live customers using Wallmob.

Sweden

- Requires integration with Infrasec to comply with the Swedish cash register legislation.
 The integration and declaration towards Infrasec is done by ExtendaGO or preferred partners.
- VAT rates are set up and adjusted annually if changed.



- Base currency is SEK.
- Live customers using Wallmob.
- Swedish translation available.

Finland

- No fiscal legislation or special rules.
- VAT rates are set up and adjusted annually if changed.
- Base currency is EUR.
- Finnish translation is available, done through customers. May have English wordings in new functions for a period of time.
- Live customers using Wallmob.

Netherlands

- No fiscal legislation or special rules.
- VAT rates are set up and adjusted annually if changed.
- Base currency is EUR.
- Dutch translation is available, done through customers. May have English wordings in new functions for a period of time.
- Live customers using Wallmob.

UK

- No fiscal legislation or special rules.
- VAT rates are set up and adjusted annually if changed.
- Base currency is GBP.
- English is the base language in Wallmob.
- Live customers using Wallmob.

Germany

- Not currently compliant. Will be when new German fiscal rules are implemented 31st of September 2020.
- Fiskaly account required at additional cost.
- VAT rates are set up and adjusted annually if changed.
- Base currency is EUR.
- Translation to German is done through a partner.
- For merchants only selling in Germany PrismaPOS (Wallmob white label) is the preferred POS. Contact Nexgen AG for further details and services in Germany.



Austria

- Not currently compliant. Will be when Fiskaly integration is implemented 31st of September 2020.
- Fiskaly account required at additional cost.
- POS registering at tax authorities must be done when rollout probably by the customer (under investigation).
- VAT rates are set up and adjusted annually if changed
- Base currency is EUR
- Translation to German is done through a partner.
- For merchants only selling in Austria PrismaPOS (Wallmob white label) is the preferred POS. Contact Nexgen AG for further details and services in Austria.

Switzerland

- No fiscal legislation or special rules.
- VAT rates are set up and adjusted annually if changed.
- Base currency is CHF.
- Translation to German, Italian and French is done through a partner.
- For merchants only selling in Switzerland PrismaPOS (Wallmob white label) is the preferred POS. Contact Nexgen AG for further details and services in Switzerland.
- Live customers using Wallmob.

France

- Not currently compliant. Will be when self declaration is approved. Estimated ready for use within September 2020.
- Fiscal legislation on logging and reports.
- No complex rules.
- Certificate must be obtained (under investigation awaiting cost and decision)
- When self declaration is obtained then ok with 3 separate reports. EST: September 2020.
- VAT rates are set up and adjusted annually if changed.
- Base currency is EUR.
- Translation to French is done through a partner.

Spain

- OK some reporting.
- VAT rates are set up and adjusted annually if changed
- Base currency is EUR
- Translation to French is done through a partner and added from Extenda Retail



Italy

- Fiscal laws.
- No certification other than fiscal printer.
- Silent Touch POS (Microsoft based) in combination with Wallmob backoffice (available in Q4 2020)
- VAT rates are set up and adjusted annually if changed.
- Base currency is EUR.

Poland

- Fiscal laws.
- No certification other than fiscal printer.
- Silent Touch POS (Microsoft based) in combination with Wallmob backoffice (available in Q4 2020)
- VAT rates are set up and adjusted annually if changed.
- Base currency is PLN
- Live customers using Silent Touch POS

New Zealand

- No fiscal legislation or special rules.
- Customers must have approval of receipt storage outside of NZ.
- If not storage of receipts must be in NZ. Local servers for storage must be set up with a NZ partner.
- VAT rates are configured upon request.
- Base currency is NZD.
- Translation to English is Wallmob's default.

Countries not supported

Hungary

- Never gonna happen!

Belgium

- Special rules when serving food. Not compliant for such businesses. Details can be shared through the country handbook.
- VAT rates are set up and adjusted annually if changed.
- Base currency is EUR.
- No Translation.



- Not recommended to use or sell Wallmob in Belgium.

Portugal

- Much like Norway but special rules on refunds, returns and sale of articles with negative cost.
- Needs development in core
- SAFT variant export
- VAT rates are set up and adjusted annually if changed.
- Base currency is EUR.
- No translation
